## **Breeders show case rules**

- Each entry shall consist of three dogs. They may be either male or female or one of each. Each entry must be a minimum of 6 months of age at time of show.
- Each dog must be entered at breed level.
- Each entry shall have at least one breeder in common. The name of this breeder must be exactly the same, but may fall in any order on the registration.
- An entry may be handled in the ring by anyone; i.e. breeder, owner or handler. If breeder is not able to show themselves they must be ringside for a valid entry.
- Each breeder may only be represented by one entry
- All entries must be registered in accordance with AKC rules for entering an AKC Sanctioned show.
