- 2 activities are required to be listed above. A meeting is not an activity, but activities can be held in conjunction with meetings. E.g. grooming seminar, match, educational speaker, supported or sanctioned events, etc.
- Bank account information – proof of a bank account, bank name and address, title of the bank account in the club's name with the Treasurer and one other officer's name on the account as specified above.
- A fiscal report that includes the opening and closing bank balance with debits and credits specifically listed for the year. If associated with an activity, it must state which activity.
- Affiliation Fee (see MASCUSA website for current fees)
